

Paintball, IR-Tag, Foamball RELEASE and WAIVER OF LIABILITY

IN CONSIDERATION of being permitted to compete, officiate, work for, or participate in any way in the EVENT(S) or being permitted to enter for any purpose the Playing area premises (Defined as any area to which admission is granted in connection with or for the purpose of engaging in paintball, IR-Tag & Foamball type activities.)

EACH OF THE UNDERSIGNED, for himself/herself, his/her personal representatives, heirs, and next of kin:

1. Acknowledges, agrees, and represents that he/she has or will immediately upon entering any such playing areas, and will continuously thereafter, inspect the playing areas which he/she enters and he/she further agrees and warrants that, if at any time, he/she is in or about playing areas and he/she feels anything to be unsafe, he/she will immediately advise the officials of such and will leave the playing area(s) and/or refuse to participate further in the event(s)
2. HEREBY RELEASES, WAIVES, DISCHARGES, AND COVENANTS NOT TO SUE the promoters, participants, management company, sanctioning organizations or any subdivision thereof, playing area field operators, playing area field owners, officials, referees, other players, management crews, rescue personnel, any persons in any area, promoters, sponsors, advertisers, owners and lessees of premises used to conduct EVENT(S), premises and event inspectors, surveyors, underwriters, consultants and others, including reps of Zebra Entertainment and Events, Mobile Combat and Cruz, Prado & Associates, Inc., who give recommendations, directions or instructions engage in risk evaluation, loss control activities or sales regarding the premises of EVENT(S) and each of them, their directors, officers, agents, and employees, all for the purposes herein referred to as "Releasees", FROM ALL LIABILITY TO THE UNDERSIGNED, his/her personal representatives, assigns, heirs, and next of kin FOR ANY AND ALL LOSS OR DAMAGE, AND ANY CLAIM OR DEMANDS THEREFORE ON ACCOUNT OF INJURY TO THE PERSON OR PROPERTY OR RESULTING IN DEATH OF THE UNDERSIGNED ARISING OUT OF OR RELATED TO THE EVENT(S), WHETHER CAUSED BY NEGLIGENCE OF THE RELEASEES OR OTHERWISE, including those claims which may arise from any alleged negligence of any Releasee.
3. HEREBY AGREES TO INDEMNIFY AND SAVE AND HOLD HARMLESS the Releasees and each of them FROM ANY LOSS, LIABILITY, DAMAGE, OR COST they may incur arising out of or related to the EVENT(S) WHETHER CAUSED BY THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE, including those claims which arise from any alleged negligence of any Releasee.
4. HEREBY ASSUMES FULL RESPONSIBILITY FOR ANY RISK OF BODILY INJURY, DEATH OR PROPERTY DAMAGE arising out of or related to the EVENT(S) whether caused by NEGLIGENT RESCUE OPERATIONS OR PROCEDURES OF THE RELEASEES. I FURTHER GRANT PERMISSION TO HAVE MY IMAGE RECORDED & USED FOR PROMOTIONAL PURPOSES BY RELEASEES.
5. HEREBY acknowledges **THE ACTIVITIES OF THE EVENT(S) ARE VERY DANGEROUS and INVOLVE THE RISK OF SERIOUS INJURY AND/OR DEATH** and/or property damage. Each of THE UNDERSIGNED also expressly acknowledges that INJURIES RECEIVED MAY BE COMPOUNDED OR INCREASED BY NEGLIGENT RESCUE OPERATIONS OR PROCEDURES OF THE RELEASEES.
6. HEREBY agrees that this Release and Waiver of Liability, Assumption of Risk, and Indemnity Agreement extends to all acts of negligence by the Releasees, INCLUDING NEGLIGENT RESCUE OPERATIONS and is intended to be as broad and inclusive as is permitted by the laws of the Province or State in which the EVENT(S) is/are conducted and that if any portion thereof is held invalid, it is agreed that the balance shall notwithstanding, continue in full legal force and effect.

I HAVE READ THIS RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK AND INDEMNITY AGREEMENT, FULLY UNDERSTAND ITS TERMS, UNDERSTAND THAT I HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT, AND HAVE SIGNED IT FREELY AND VOLUNTARILY WITHOUT ANY INDUCEMENT, ASSURANCE, OR GUARANTEE BEING MADE TO ME AND INTEND MY SIGNATURE TO BE A COMPLETE AN UNCONDITIONAL RELEASE OF ALL LIABILITY TO GREATEST EXTENT ALLOWED BY LAW.
